**AGE RESTRICTED FIREFIGHTER PROGRAM**  
**Rules & Regulations**

1. All applicants must be a resident of the Monticello Fire Department protection boundaries.
2. All age restricted members will be classified as members of the Monticello Fire Department and must conform to the Constitution and By-laws of the Monticello Fire Department.
3. All age restricted members must be at least sixteen (16) years of age and not more than eighteen (18) years of age.
4. Application for age restricted membership must be filled out by the applicant and returned with proof of age and proper fee. The fee of twenty-five (25) dollars must be paid when the application is submitted for approval. The application fee is refundable if applicant is found to be not eligible for membership to the Monticello Fire Department (this fee does not include the annual membership dues to the Monticello Fire Department which is collected annually by the Financial Secretary). The application MUST be completed fully in order to be considered for membership. Once the application has been submitted for review, it will take the same course of action as an applicant for active membership.
5. The Fire Department will not tolerate or be responsible for traffic violations incurred by members at any time.
6. No age restricted member will be permitted to drive or operate any Department apparatus.
7. No age restricted member shall be permitted to enter any burning building, burning field or danger area.
8. When on a fire scene, the age restricted member must report the officer in charge for accountability.
9. Age restricted members will be issued blue light certificates and must conform to the same rules & regulations as active members, as specified in NYS Vehicle & Traffic Laws. Failure to abide by or abuse of the privilege will result in instant revocation.
10. Age restricted members will be responsible for the action of their guests.
11. Age restricted member requirements of a minimum of thirty percent (30%) of drill & meeting attendance must be maintained. There is no requirement for fire attendance. If the percentage is not met, the member will be brought in front of the Council for review.
12. No age restricted member will be allowed to vote for line officer of the Monticello Fire Department at annual elections. Age restricted members will have voting rights for civil officers.
13. Age restricted members will not be allowed to hold elected office in the Department.
14. No age restricted member shall be allowed to respond to the scene of a fire or emergency until successful completion of mandatory OSHA training.
15. Age restricted members shall abide by the standing Standard Operating Guidelines when riding on fire apparatus. Active members will have priority in seating on any apparatus responding to an emergency.

Rules & Regulations (cont.)**

16. No age restricted member shall respond to a call during school hours. Age restricted members are also not to be at the firehouse or any fire department function while school is in session. The Monticello Fire Department will not in any way hinder the education of any member. School work will take precedence over any fire department function.
17. Age restricted members will present their grades to the Council every marking period for review. A 2.0 minimum grade point average will be required. Should the GPA fall below 2.0, the member will be placed on a leave of absence until the next marking period where improvement is made.
18. A 10:00 P.M. curfew will be enforced during the school week. A 12:00 A.M. curfew will be enforced on non-school nights.
19. Any age restricted member can and will be suspended at the written request of the parent or legal guardian for any reason.
20. Upon reaching eighteen (18) years of age, the age restricted member will, upon recommendation of the Council and approval of the membership of the Department, attain full active membership. At this time, a probationary period of one (1) year shall be in effect.
21. The age restricted firefighter program will not exceed eight (8) members at any one time.
22. Turnout gear will be provided to age restricted members and will be so marked. This gear shall be OSHA approved and will be suitable as identification on the fire scene.

***I have read the above rules and regulations and will abide by them as written, unless ordered otherwise by an Officer of the Monticello Fire Department. Should any questions arise, or situations exist which I do not understand, I will ask the Officer in Charge for clarification.***
